The Northeast Nebraska Network Consortium has developed Nebraska Connect; which is a system that enables schools and ESU's to easily connect up to the Nebraska Cloud system using the Microsoft Active Directory Federation Services technology.

The solution developed has attracted the interest of other non-NNNC ESUs and schools. This brochure describes the process and answers some frequently asked questions for those who want to partner with or mimic the NNNC implementation.


Nebraska Connect relies on a Microsoft Active Directory environment. We realize that many schools do not currently have a Microsoft environment, especially many smaller districts that have focused on Apple or Google Chromebooks. But not to worry; implementing our solution, including a Windows server environment, will not impose a steep learning curve or high cost.

For those districts who do not feel comfortable in managing their own Microsoft Active Directory environment directly, Nebraska Connect has developed customizations to PowerSchool and Infinite Campus that can be used. This permits the school to easily manage their user accounts without ever needing to touch their Windows server.



Frequently Asked Questions

Q: How many servers are required?

A: A minimum of two; a Windows domain controller and a Windows ADFS server

Q: Do the servers need to be in my building?

A: The two servers need to be on the same network segment so they can communicate with each other. You can have both servers in your building, both servers at your ESU, or any combination as long as your servers are on the same network segment.

Q: What else can I do with this technology?

A: Each ADFS server is a stand-alone identity provider. This means that you can connect up to any number of services that are compatible to ADFS in addition to the Nebraska Cloud system.

Q: What online apps are compatible with Nebraska Cloud?

A: While Nebraska Cloud is still in development phases, it is anticipated to be compatible with many apps. For example:
